Due to economical and operational conditions, Strata Production Company requests approval to Temporarily Abandon the well for the period of one (1) year to evaluate offset drilling and potential for waterflood injection.

The pump jack, pump, rods and heater treater have been removed. The wellhead and tubing remain intact.

Within 90 days of approval, the Hobbs BLM will be notified within 48 hours prior to commencement of operations to witness the following procedures:

1. A bridge plug will be set at 6894', and the wellbore filled with conditioned, non-corrosive fluid and shut-in at the surface.
2. The casing and uppermost plug will be pressure tested to a minimum to 500 psi for 30 minutes.
