Drilled 11" hole 815' to 4537'. TD reached 0130 hrs CST 11/13/93. Ran 101 jts 8-5/8", 32#, S-80 & J-55, ST&C casing. Float shoe @ 4537'. Float collar @ 4491'. Howco cemented casing with 1600 sx Halliburton Lite @ 12.7 ppg followed by 200 sx Class "C" + 5 pps salt @ 14.8 ppg. Plug down @ 1430 hrs CST 11/13/93. Recovered 280 sx excess cement. WOC 5 hrs. Make cut-off. Weld on wellhead and test to 1000 psi. NU BOP's and test to 1500 psi.
