Tailed w/ 200 sxs "C" w/ 5 pps salt 14.8 ppg. Circ 300 sxs excess. Total WOC 14-1/2 hrs. Cmt compressive strength is in excess of 500 psi in 8 hrs. Test BOP's to 1500 psi.
