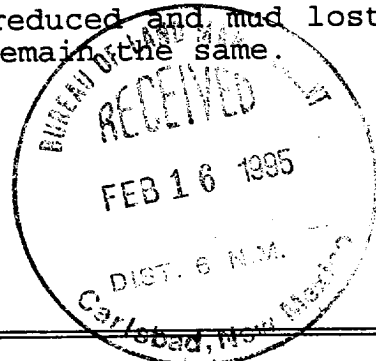

Pogo Producing Company request permission to alter the APD of the above described well so that the 7-7/8 portion of the well may be drilled with produced salt water. This water, as the attached analysis shows, is very high in chloride content and will cause no adverse affect to the formation. Air will be introduced to the mud stream so that hydrostatic pressure can be reduced and mud lost minimized. All other plans on the APD will remain the same.
