Burlington Resources plans to frac the Bone Spring perms as follows:

MIRU workover rig. TOH with rods and pump. TIH with 3 7/8" bit, casing scraper, and tubing to PBTD (~8975'). TIH with Halliburton frac liner, setting tool and tubing. Set liner to cover Delaware perforations from 8501' to 8531'. RU Halliburton and frac Bone Spring perms 8832' - 8884' down 4 1/2" casing with 41,000 gals Delta Frac 25 and 73,400 lbs 20/40 Super DC RC sand. Latch into frac liner and release. TOH. Clean out to PBTD (~8975'). RU reverse unit and foam air unit to establish circulation. TIH with previous tubing. TIH with previous pump and rod design. Return well to production.
