1/16/98: Tagged cement at 8440'. Drilled cement retainer and cement to 8534'. Circulated hole clean. Tested casing to 1000# for 30 minutes—holding.

1/17/98: Drilled CIBP and cleaned out to 8965', Bone Spring perfs 8832' - 8884'.

1/19/98: Set 2 3/8" tubing at 8812'.

1/20/98: Swabbed.

1/22/98: TIH with RHBC pump and rods. RU pumping unit and turned to production.
