Squeeze perfs 8559'-8609' w/ 150 sx Class H (Premium) cement containing 0.5% Halad 322 tailing in w/ 100 sx Class H (Premium) neat cement. WOC. Drill out retainer and cement. Test squeeze to 1000 psi. Drill out CIBP and push to bottom @ 8975'. Set 2 3/8" tubing @ ~9000'. RIH w/ pump and rods. Return well to production.
