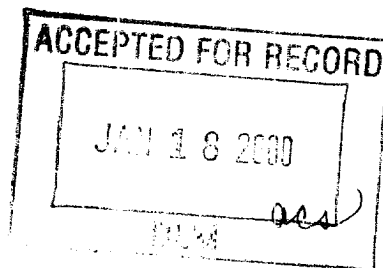

This well was recompleted as a Wildcat Seven Rivers. Upon completion the well was placed in the Warren-Seven Rivers Gas Pool, Pool code 96812 by Division Order R-11116, effective January 1, 1999. On June 30, 1999 the well was determined to be capable of producing unitized substances in paying quantities from the Seven Rivers. The well established a new participating area within the Warren unit. The new participating area is called the Eumont Participating Area and encompasses the SE 1/4 of Section 28, 160 acres.
