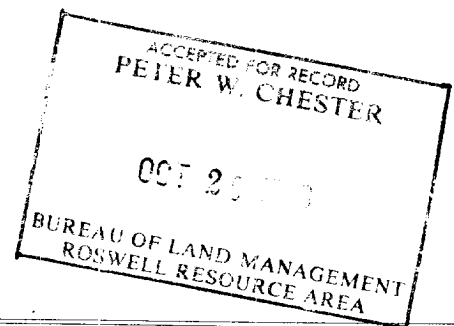
04/22/97 Latch onto RBP @ 8047' & reset @ 7585'. Perf Delaware 7338'-48' (20 - .38" dia holes).

04/25/97 Circ well clean. Swab test.

04/27/97 Run production equipment. Put well on pump.
