3. Drill 4900' of 9 7/8" hole and set 4900' of 7 5/8" 26# J-55 & N-80 ST&C casing. Cement with 1350 Sx. of cement with additives. Circulate cement to surface.
4. Drill 9400' of 6 3/4" hole and set 9400' of 4 1/2" 11.6# J-55 & N-80 LT&C & ST&C Casing. Cement with 1100 Sx. of cement with additives. Bring cement back to 4000'.


