6-26-96: Ran 4650' of 5 1/2", 15.5#, K-55 casing, cemented with lead slurry 455 sx CI C + 18% gel + 3% salt + 2/10% CD-32 + 3/10% SMS. Tail slurry 480 sx CI C + 1.1% FL-62 + 3% salt + 2% BA-90 + 3/10% CD-32 + 2/10% SMS. Circulated 50 sx to pit, rig released 5:00 am 6-26-96.
