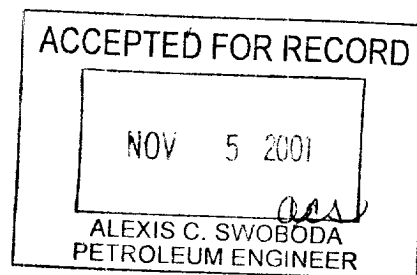

6-1-01: Perforated 7 Rivers 4 spf @ 3009-17', 3023-38', 3043-50', 3060-62', 3065-68', RDWL. Acidized 7 Rivers w/2500 gals 15% NEFE HCL & ball sealers. SI.
