Drilled 8 3/4" hole to total depth of 3,745' RKB. Logged well with CNL-LDT-GR log and DLL-MSFL-GR log. Computed cement volume = 1,305 cu.ft. Circulated hole and pulled and laid down drill string. Ran 7" O.D. casing string consisting of 88 jts. (3,745.55 ft.) of 7" O.D., 23 lb/ft, J-55, LT&C casing, HOWCO SS-II guide shoe, HOWCO SS-II float collar, and 18 centralizers. Landed bottom of casing string at 3,745' RKB with float collar at 3,718' RKB. Cemented casing at 10 BPM with 1,900 cu.ft. of cement slurry (46% excess) consisting of 625 sx of 11.5 lb/gal API class-C cement containing 3% econolite, 5 lb/sx gilsonite, 1/2 lb/sx flocele followed by 350 sx of a 14.1 lb/gal 50/50 blend of API class-C cement and Pozmix "A" containing 18% salt and 1/4 lb/sx flocele. Plug down at 7:50 P.M. CDT 8/26/96. Circulated 300 sx of excess cement to pit. Pressure tested casing to 1,500 psi. Pressure held okay. Released pressure and float held okay.
