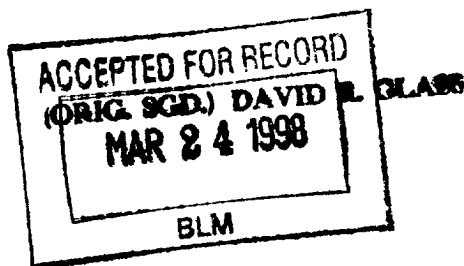

7-8-97: Fraced lower San Andres with 57,000 gals Spectra G-3500 & 142,000# 16/30 Ottawa sand & 22,000# SLC RCS sand.

7-9-97: Clean out fill to PBTD to 4701', ran in hole with production tubing, prep to run pump and put well on production.
