


CENTERLINE DESCRIPTION OF A PROPOSED ELECTRIC LINE:

BEGINNING at an existing electric pole, from which point the northeast corner of Section 29, T-20-S, R-38-E, N.M.P.M., Lea County, New Mexico, bears N 89° 56' E, 1973.8 feet and N 00° 03' 41" W, 567.6 feet, and an anchor easement bears S 00° 55' 32" W, 30.0 feet;

THENCE N 00° 55' 32" W, 437.5 feet to a bend, from which point an anchor easement bears N 00° 55' 32" W, 30.0 feet and another anchor easement bears N 89° 11' W, 30.0 feet;

THENCE S 89° 11' E, 265.0 feet to an existing pole in a North-South, East-West electric line, for a bend;

THENCE S 03° 59' W, 50.0 feet to the end of this line, from which point an anchor easement bears S 03° 59' W, 30.0 feet and the northeast corner of Section 29 bears N 89° 56' E, 1718.9 feet and N 00° 03' 41" W, 84.1 feet.
