RU BJ & cement w/ 1250 sx Poz "C" followed by 300 sx C1 "C". Bumped plug w/ 760#, floats held. PD at 11:15 p.m. MDT. Note: BLM notified but did not witness.

8/15/98: WOC. Jet and clean pits, remove bolts from hydril. Cut csg off and install 12" 3Mx13-3/8" SOW. Tested to 1200#. NU spacer spools, annular BOP, kill line, flow line, and manifold. PU BHA & TIH. Test csg to 1000#, ok. Drlg cmt & float. WOC total of 24 hrs. Resume drilling formation.
