BLM notified, but did not witness. RD pack-off. TOH w/ DP. Clean pits. WOC.

8/08/98: Cut off 30" cond. and 20". Weld flange on 20". NU mud cross, hydril, riser, and flowline. LD DP from derrick. TIH w/ BHA. Test csg to 800 psi, ok. WOC total of 24 hours. Drlg float and cement. Resume drilling formation.
