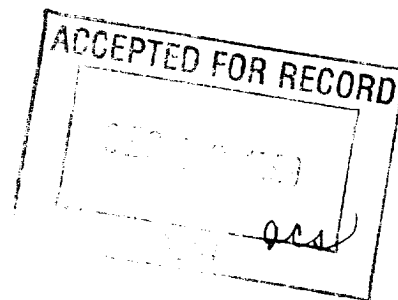

10-26-99: MIRU - rigged up pump truck, pumped 44 bbls 2% KCL water to kill well. Installed BOP, tested BOP to 1000#-held, unset packer, POOH w/packer, picked up and ran in hole with 5'-2 7/8" SOPMA, 2 7/8" seating nipple, tubing anchor, L-80 tubing, tagged bottom @ 7680', pulled up and landed seating nipple @ 7672', tubing anchor @ 7444', spaced out pump.

10-28-99: Ran rods in hole. well put on production.
