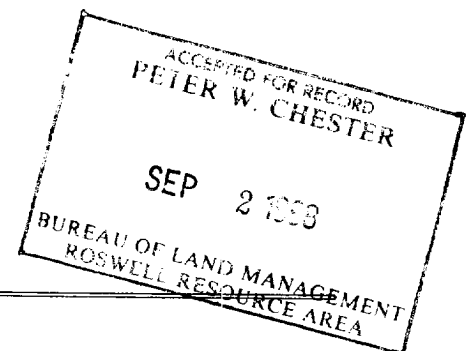

Cement returns - 27 sx. Bumped plug with 2600 psi. WOC.
