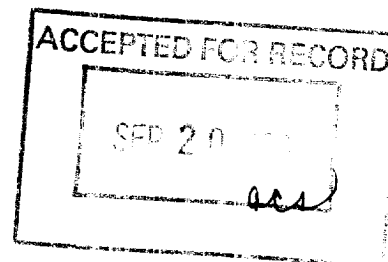

9-3-99: Ran 1404' of 8 5/8", 23#, M-50 casing, cemented with lead slurry of 520 sx, 35:65 POZ, CI C + 2% bwoc CaCl2 + .25% bwoc cello-flake + .005 gps FP-6L + 6% bwoc bentonite. Tailed with 195 sx CI C + 2% bwoc CaCl2 + .005 gps FP-6L. Tested casing to 890 psi. Floats held OK, WOC.
