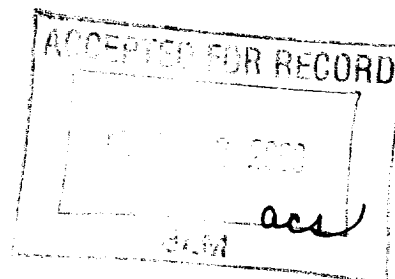

5-2-00: Moved in, rigged up, spudded 12 1/4" hole.

5-3-00: Ran 9 5/8" casing to total depth of 1485'. Cemented with 400 sx CI lead cement, tailed with 150 sx CI C cement. Displaced with 112 bbls of fresh water, bumped plug and floats held. Circulated 60 sx of cement to reserve pit. WOC, tested BOP to 300 & 2000 psi, tested annular to 1000 psi., tested casing to 1500 psi -held good.
