

Conoco, Inc. proposes to drill and complete the Meyer B 31, Well #6 in the North Hardy Strawn pool. There is an existing production facility for the Meyer B 31, Well #5, which was constructed upon completion of Well #5 in May, 2000. The facility is located in the NW/4 of Section 31 (see map attached). The most cost effective and environmentally sound method of producing Well #6 will be to add the anticipated oil, water and casinghead gas production to the existing facility. As specified on the enclosed battery/facility diagram the production from each well will be continually metered, assuring the production allocation to each well will be accurate.

The royalty and working interest for the proration unit allocation for Well #6 is different than the ownership in Well #5, as specified in the attached ownership listing for Section 31, T20S, R38E, Lea County, New Mexico.






LEGAL DESCRIPTION
