Request setting of surface casing to depth of 650'. Drill surface hole with spud mud weight 8.6 to 9.2, viscosity 34-36.

After setting surface and cementing back to surface will drill out with spud mud to top of Rustler formation. Upon encountering Rustler will change to brine water wt 10 ppg, viscosity 30. Will set 9-5/8" intermediate @ 5100 and circulate cement to surface.
