Run 20' cement plug at 4030 to 4050' let set 48 hrs. bail hole dry, let set 2 hrs. hole remained dry. Set 20' cement plug at 3610 3630. Fill hole with mud to 1990' & run 20' cement plug. Fill with mud to 200' run 20' cement, fill hole with mud & cement top of hole, erect monument.
