This well was drilled as *Superior Oil Co.* *Alameda*-State to a total depth of *4184'* and plugged and abandoned.

Operator proposes to attempt completion in the *Yates* sand at *4027-35'*.

Operator will drill out cement plugs with reverse circulation unit, & test *Yates* sand. If the sand is found productive, operator will run *4 1/2"* casing to approximately *4050* and cement with *50* sacks; will perforate and *irac* pay zone.

Old well had *7" OD* casing set at *2285* and cut-off at *2135*. *6 1/2"* hole *2285* to *4184*.
