**Spudded Nov. 1, 1947 and drilled to 175' when we lost string of tools (stuck in hole) and could not recover. In attempting to drill by, lost a second string some of which we recovered by shooting off our pin on bottom of jars. On Nov. 16 we plugged hole with mud and four feet of cement at top with 4 inch pipe as required Skidded 90' east of location xSpinned Spudded in again Dec. 1st 1947**
