Present total depth of subject well 3713'. The water-oil ratio has increased to a relatively high point. In order to reduce the water-oil ratio, permission is requested to deepen State 26, not to exceed 4000'. Permission is also requested to acidize, shoot, or hydrofrac as completion operations require stimulation. It is the intent to use packer for water shut off rather than liner with perforations.
