Detailed account of work done, nature and quantity of materials used, and results obtained.

The subject well was logged and perforated at various points from 3707-08, 3713-14, 3718-20, 3720-24, 3850-52, and 3856-60. It was determined from testing these zones that there was communication between the perforations behind the 9 5/8" casing. This interval in the formation is made up of Seven Rivers reefing dolomites and from past experience it would be impossible to obtain a satisfactory cement squeeze job. The well is now temporarily abandoned. We are awaiting the possibility of re-entering and cleaning out the well for an attempted completion in the Morrow sand.
