DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On November 25, at 4:00 PM, 45 hours had elapsed since setting 124 feet of 16" OD 70# SH Casing and cementing with 200 sacks to be used as surface string. At this time, casing shut-off was tested as follows:

The hole was bailed dry before and after drilling cement plug, allowing to stand one hour after each bailing. As casing shut-off tested OK, drilling operations were resumed.
