Detailed account of work done, nature and quantity of materials used, and results obtained.

Refer C-102 December 7, 1964. A bridge plug at 3812 feet was drilled out. The zones from 4528-4748, 4340-4560, 4090-4310 and from 3900-4120 were each acidized with 3,000 gallons of 15% NEA acid by use of Lynes straddle packers. Reda pump model 59-G was set on 3" tubing at 1530 feet with the intake at 1492 feet. In 23 1/2 hours the well pumped 7707 barrels of water at a rate of 5.5 BPM. The Reda pump was removed on January 14, 1965. The well will be plugged back to approximately 3880 feet with the packer at 3840 feet in an effort to develop oil production.


