Subject well was drilled to total depth of 4308', penetrating the reef lime. Drill stem test was made 11-24-45, tool open one hour, sulphur water rose 2790' in drill pipe with no indications of oil or gas.

We propose to plug and abandon in the following manner: Place a 35-sx. cement plug at bottom, filling back to approximately 4200', and with hole filled with heavy mud laden fi fluid. spot a 15-sx. cement plug in bottom of 9-5/8 casing set at 1867' w/ 250 sx. Recover as much of this pipe as possible (estimated) 800' and place a 15-sx. cement plug in top of 13-7/8 surface casing set at 210' cemented to cellar floor with 200 sacks. This string will be left intact, and a 4" pipe marker will be set in cement to extend 5' above ground level. Cellar and pits will be filled and the location leveled to conform with surrounding terrain.
