3870' T.D. Line - 3862' D.O.D.

Finished 8-3/4" hole to 3870' @ 6:15 PM, 9-7-54. Ran 128 jts. of 7" OD Csg. set @ 3870' w/800 sacks cement. Pumped plug to 3805' @ 4:30 PM, 9-8-54. Max. Pressure 600#. Ran temperature survey and found top of cement @ 2231', or 26.64% fill. WOC 24 hours. Tested 7" OD Casing w/1000# before and after drilling cement - OK. Drilled plug and cement from 3805' to 3862' and circulated hole clean, 5 AM, 9-10-54. Continued with completion operations.
