Finished drilling 3-3/4" hole @ 8:45 PM, 8-24-54. Ran 7 jts. of 9-5/8" OD Casing set @ 307' w/300 sacks cement. Pumped plug to 285' @ 12:45 AM, 8-25-54. Max. Pump Pressure 200#. Cement Circulated. WOC 12 hrs. Tested 9-5/8" OD Casing w/800# before and after drilling cement. Ho'd OK. Drilled plug and cement from 285' to 307' and washed to bottom, at 312'. Started drilling formation and 8-3/4" hole @ 5PM, 8-25-54.
