4150' - T.D. 4148' - DOD - Lime & Sand -

Finished drilling 8-3/4" hole to 4150' @ 6:45 PM, 5-21-54. Ran a total of 137 jts of 7" OD Casing set @ 4150'. Cemented w/800 sacks. Pumped plug to 4092' @ 10 AM, 5-22-54. Max. Pressure 800#. Ran temperature survey and found top of cement outside 7" Casing @ 2097', or, 32.6% fill. WOC 24 hours. Tested 7" OD Casing w/1000# before and after drilling cement - OK. Drilled cement from 4085' to 4148'. Continued with completion operations.
