DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to 325' and ran 314.19' of 8-5/8" O.D. 24# J-55 casing set at 325.19'. Halliburton cemented casing with 225 sacks of Longhorn Portland cement with 2% calcium chloride. Plug down to 300' at 5:15 P.M. 7-10-56. Cement circulated. Tested blow out preventer and casing with 1000# for 30 minutes ending 10:30 P.M. 7-11-56. Drilled cement plug and under surface. Pumped into formation with 400#. Resumed drilling.
