DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 9 joints of 9-5/8" O.D. 36# H-40 ST&C casing with Larkin guide shoe. Total pipe 300.38' set at 310.88'. Halliburton cemented with 200 sacks of Lone Star cement with 2% calcium chloride. Plug down to 300' at 4:20 P.M. 2-2-57. Cement circulated. WOC 24 hours. Tested casing from 10 to 10:30 P.M. 2-3-57 with 1000#. Test OK. Drilled shoe at 310' and pumped into formation at 600#. Resumed drilling.
