A twenty sack cement plug will be set at this point, the hole filled with mud to the surface and a 10 sack cement plug with regulation marker set.

Gentlemen:

Your proposed plan of abandonment of subject well approved  
subject to the following provisions:

1. If lead wool used set in base of 7" casing and dump three (3) sacks cement on top. Lead wool by itself is unsatisfactory as a positive plug.
2. If 16" surface pipe is pulled from well surface cement plug must fill up a minimum of thirty (30) feet. If surface pipe is left in hole surface cement plug must fill up a minimum of thirty (30) feet. The cement plug in stub of 7" casing will still be required and mud between all plugs.
