DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Set retrievable retainer at 3762' and cemented 4 stages; 1st stage- 100 sax, 2nd stage - 75 sax, 3rd stage - 75 sax; and 4th stage - 200 sax. Got good squeeze to 500 p.s.i. Drilled out cement plug from 3762 to 3816'. Cleaned out to 3867 but no solid cement below 3816'. Tested with Dowell spinner and found fluid going out between 3840 and 3846. Sand oiled w/10,000 gallons Famariss oil and 20,000 lbs. sand - down the casing.
