Gentlemen:

Please consider this letter our application for commission approval of a dual gas-oil completion for The Superior Oil Company - State #1-175 well, located 66 0' FEL & 1980' FEL, Section 11, T-21-S, R-35-E, Lea County, New Mexico. Also please consider this as an application for approval of a non-standard gas production unit embracing 160 acres being the NE 1/4, Section 12, T-21-S, R-35-E, Lea County, New Mexico.

Attached hereto is a plat showing acreage to be dedicated, the well location, and offset ownership. Also attached is a diagrammatic sketch of the proposed dual completion.

If approval of this application is obtained, applicant proposes to dually complete its State #1-175 well in the Basal Yates Gas Zone perforations 3780-90' and the Upper Seven Rivers Oil Zone perforations 3894-70' by setting a hookwall packer at approximately 3880' and using an Otis Type "F" nipple with a straight-thru choke just above the packer. The gas will flow up the annulus between 2 1/2" EUE tubing and 7" casing, while the oil will flow up the tubing.
