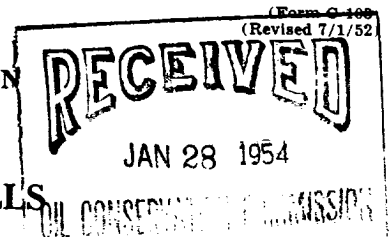

314' T.D. - Red Bed- Finished drilling 13-3/4" Hole to 314' @ 7:30 P.M., 1/21/54. Ran a total of 7 jts of 9-5/8" OD Csg set @ 312' W/200 sacks of cement. Pumped plug to 291' @ 12:30 A.M., 1/22/54 - Max pressure 200#. Cement circulated. After WOC for 12 hrs tested csg W/100#, before and after drilling cement - OK. Drilled cement from 291' to 314'. Started drilling formation and 8-3/4" hole from 314' @ 11:45 P.M., 1/22/54.
