DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Due to decline in production this well was shot with 370 quarts from 3799' to 3879' and, after cleaning out, the tubing was rerun with an American Flow packer set from 3664-68'. As a result of this work the well made 120 barrels of oil in 8 hours with a gas-oil ratio of 2470 cubic feet per barrel.
