 Ran Schlumberger's Surveys - Ran a total of 126 Jts of 7" OD 23# casing set @ 3960' W/400 Sx. Pumped plug to 3899' @ 11:45 PM, 7/24/53 - Max pressure, 800#. Ran temperature survey, top of cement outside 7" casing @ 2432', or, 39.8% fill. After WOC 24 hours, tested 7" casing with 1000# - no pressure drop. Drilled cement from 3899' to 3959', and tested casing for 1/2 hour with 1000# - OK. Continued with completion operations -
