3. Treated formation via casing w/20,000 gallons lease oil containing 2# sand & 1/40# FL-2/gallon in 5 stages using ball sealers.
4. Ran 2" tubing w/HD-100 packer to previous setting.
5. Recovered load.
6. In 16 hours flowed 39 BO, cut 0.5% BS&W, thru 28/64" choke.
