2. Set CIBP at 3850' on wire line.
3. Spot 250 gallons 15% MCA on bottom.
4. Perforate at 3822', 3831' and 3839' w/4-way jet.
5. Treat down 5 1/2" casing w/20,000 gallons lease crude containing 1.5% sand/gallon and FIA.
6. Shut in overnight.
7. Run tubing, swab test, and place on production.
