DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 3953' of 5 1/2" casing and cemented at 3965' with 700 sacks of 4% gel and 100 sacks neat cement. Did not circulate cement. After WOC 24 hours determined top of cement at 1140' by stretch test. After WOC 48 hours tested casing with 1200 psi for 30 minutes. Test OK. Drilled out cement to 3950' and tested with 1200 psi for 30 minutes. Test OK.
