We plan to set plug in bottom of hole above top perforations in 5 $\frac{1}{2}$ " casing (3,782') then pull pipe at a point where it is free above return of cement around 5 $\frac{1}{2}$ " casing (cement back to 3,150') after pulling 5 $\frac{1}{2}$ " casing go back in hole to where pipe was pulled with tubing, set cement plug, then set cement plug at bottom of surface casing (308 ft.), then put plug in top of 8-5/8" surface casing.
