Reference is made to your application dated June 12, 1957, for a 120 acre non-standard gas proration in the Eumont Gas Pool for your State "F-1" Well No. 4 in Lot 1 of Section 1, Township 21 South, Range 36 East. This application is being processed as NSP-374 and will be issued on July 14, 1957 if no objection is received.

Our records reflect that the proposed non-standard gas proration unit consisting of Lots 1, 2 and 7 of said Section 1 contains only 114.09 acres rather than 120 acres. If we do not hear from you in this matter, we will assume you are agreeable to the assignment of only 114 acres to this unit for allowable purposes upon completion.
