Rig up, pull tubing and packer. Check total depth, clean out w/Cavins bailer if necessary. Rerun tubing w/packer and holddown. Packer approximately 3710, tubing OE @ 3780'. Treat w/20,000 gal. Dowell Sandifras 1# sd/gal. Approximately 1in/j. Rate 8 BPM. Leave well shut in over night. If well not flow, pull packer and holddown, rerun tubing. Swab and test.
