DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Pulled tubing and made temperature survey of hole, which showed base of gas to be 3782'. Ran tubing and killed well with oil. Pulled tubing and re-ran with a Guiberson collapsible Spiral Oakum packer which was set at 3789'. Pumped 200 gallons of Dowell Packer Seal in on packer, followed by 20 bbls. of oil.

Results: Before setting packer and seal, well had a gas-oil ratio of 16480/1.

After: On August 31, 1938, flowing at rate of 67 bbls. per day thru 10/64" choke, 600# Tubing pressure, 800# csg., well tested to have gas-oil ratio of 3434/1.
