DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

8-5/8" OD casing was set and cemented at a depth of 2579 feet; and after having set for 48 hours, casing was tested for water shut-off, using a pressure of 1000 pounds, closing valves, and allowing to stand 30 minutes. Test was satisfactory as pressure did not drop more than 100 pounds during this period.
